Meanwhile, veterans with service related injuries are members for life at no cost to them.

The MPVA's Veterans Services Program has worked to secure benefits valued into the millions in new and current benefits claims. This program is conducted through MPVA's Service Officers who assisted local veterans with free services in filing or re-filing claims for VA benefits. MPVA reaches

Combining expertise and experience, the staff at the MPVA seeks to ensure that the needs of our members are considered as public officials debate issues and develop policies. We work to guarantee that benefits and rights of all veterans and citizens with disabilities are protected.
