It took Noah Currier all of six years to get out of his 'funk". Six years after the traumatic accident that paralyzed him from the chest down, former Marine Corporal, Currier finally found the drive to get back into competitive sports and has been "Oscar Mike" ("on the move") ever since.

After joining the Marine Corps in 2000, Noah was among the first soldiers deployed to Afghanistan following the attacks of September 11. As a gunner for Charlie Company, he was subsequently deployed to Iraq in 2003 as part of the leading combat units, the "tip of the spear." He returned to Camp Pendleton after seven months in Iraq—days later, a trucker fell asleep at the wheel and Noah suffered a C-6 spinal cord injury.

Six years later Noah finally let go of the funk that was holding him back and, as he says, "became addicted" to sports. Thanks to friends at Paralyzed Veterans of America (Paralyzed Veterans), Noah regained his motivation to play competitive sports. Since then, Noah has been involved in weightlifting, rowing, skydiving, skiing and his personal favorites, rugby and hand cycling.

It's therefore appropriate that Noah would found a company named after the military term "Oscar Mike." Oscar Mike is a military apparel company that makes, designs, and prints its military-themed T-shirts and "hoodies" in the United States. The company officially launched on Veterans Day 2012. Proceeds from Oscar Mike go on to support Veteran Service Organizations, including the PVA!




# Executive Pirector's Report

## Veterans Vews

### VA and Mental Health Awareness

The non-stop coverage of deaths of two highprofile people by suicide has managed to refocus the public's attention on mental health illness and how we discuss it and deal with it. Suicide is among the leading causes of death affecting military service members in the United States. According to the government, veterans who are in their first year of civilian life commit suicide nearly twice as much as other veterans, and veterans are twice as likely to commit suicide as those who never served. Recent estimates suggest that 20 to 22 veterans may die by suicide each day. Nearly 30,000 Americans commit suicide every year and on average, 1 person commits suicide every 16.2 minutes and about 2/3 of people who complete suicide are depressed at the time of their deaths.

This May, the U.S. Department of Veterans Affairs (VA) emphasized the positive impact of mental health treatment through a video campaign spotlighting hundreds of Veterans who have stepped forward to combat the stigma around mental health that is still deeply entrenched in American culture, in recognition of mental health month. The video histories found on www.MakeTheConnection.net document in extraordinary detail the human spirit's ability to overcome significant trauma. The stories also aim to inspire, influence and shape communities, culture and policies for those who may be suffering from mental illness.

The VA also recently announced that the White House approved an interagency plan to implement President Trump's January 2018 executive order titled, "Supporting Our Veterans during their transition from Uniformed Service to Civilian Life." This order provides that VA, Department of Defense and Department of Homeland Security will collaborate to provide seamless access for Veterans to mental health care and suicide prevention resources for a full year after separation from uniformed service to civilian life, regardless of verified service connection.

Overall, VA is encouraging citizens to help mobilize their communities in support of understanding that mental health treatment can work and recovery is possible. Veterans and their family members and friends can take the first step to learn more about mental health and find local resources by visiting www. MaketheConnection.net. Make the Connection is also on VA's Facebook, Instagram and YouTube platforms.

Remember, everyone can play a positive role in suicide prevention. All communities, peers, close associates, and the media are critical in preventing death by suicide. Be mindful of risk factors such as mood and anxiety disorders, alcohol and drug abuse, prior suicide attempt, stressful situations (e.g., childhood trauma, traumatic experiences, medical issues such as treatment

for depression or PTSD, relationship problems, legal issues, financial troubles), and physical health problems. If you are concerned about a friend or loved one:

- Be direct. Talk openly and matter-of-factly about suicide.
- Be willing to listen. Allow expressions of feelings.
   Accept the feelings.
- Be non-judgmental. Don't debate whether suicide is right or wrong, or whether feelings are good or bad. Don't lecture about the value of life.
- Get involved. Become available. Show interest and support.
- Don't dare him/her to do it.
- Don't act shocked. This will put distance between you.

- Don't be sworn to secrecy. Seek help.
- Offer hope that alternatives are available, but do not offer general reassurances such as, "it will get better" or "it could be worse."
- Get help from persons or agencies specializing in crisis intervention and suicide prevention, such as the Military Crisis Line.

Veterans who are in crisis or having thoughts of suicide – and those who know a Veteran in crisis – can call the Veterans Crisis Line for confidential support 24 hours a day, 7 days a week, and 365 days a year. # Government Relations & Advocacy

### The Veterans Tribute of Oakland Township

n July 31, 2018 the Michigan Paralyzed Veterans of America attended the Oakland Township veteran's dedication ceremony of the *Veterans Tribute Memorial* to honor the patriotism and valor of military veterans who made the ultimate sacrifice on our behalf.

The dedication ceremony featured patriotic music from the Adams High School band, a U.S. Air Force F16 flyover, posting of colors and first flag raising from USAF Honor Guard.

Despite rainy weather, hundreds of people gathered at the site at 5236 Adams Road to view the monument: six glass panels honoring the Army, Navy, Marines, Coast Guard, Merchant Marines and Air Force. The *Veterans Tribute Memorial* also recognizes the Michigan Paralyzed Veterans of America contributions to disabled veterans by placing our name on the wall of the memorial.

This is a result of Oakland Township residents forming a Michigan non-profit corporation, The *Veterans Tribute of Oakland Township* (VTOT), with the goal of erecting a lasting tribute to military Veterans in the Township.

The focal point of the tribute is six massive glass panels, 14-feet tall and 4-feet wide, one for each of the Military Services – Army, Navy, Marines, Coast Guard, Merchant Marines, and Air Force in ascending order of their dates of commission. Each glass panel is laser inscribed with the Service crest, the date the Service was established and the Service's motto. These glass panels are lit with internal LEDs so each will glow with the etchings highlighted.

The glass panel's rise from a semicircular granite base on which the words, "UNITED STATES ARMED

FORCES" are inscribed in large letters. At the center of the radius is a large American flag in a granite base with the words "FOR GOD and COUNTRY" as well as an inscription to honor Disabled Veterans. Walkways and the Tribute grounds will be paved with bricks, which can be purchased and laser-engraved for individual recognition.

The residents of Oakland Township and Oakland County have been extremely generous. Local and regional businesses have been equally generous – having contributed material, services and pledges to construct significant portions of the Tribute.

Hopefully future generations will be inspired by the sacrifices made on their behalf that they will honor their memory by giving back to their communities. If the veteran's memorial can achieve one thing it is

elevating the idea of service to our country, making it something meaningful, something to be proud of.

It is our responsibility to ensure that our children and grandchildren appreciate the sacrifices made by those serving our country and never forget them. Each year, as the percentage of our population who has worn a uniform declines, fewer and fewer individuals and families have a personal connection with the military. Instilling in America's youth an awareness of the contributions of veterans past and present becomes even more important.

Even though many Americans will not serve, knowledge of those who have served is essential. The traits we learn from veterans - courage, honor, duty, sacrifice, patriotism, heroism - are characteristics that make us better citizens. Their everyday acts inspire us to reach beyond our limits. Their losses remind us to live a life worthy of their sacrifice. And through their service on our behalf, we remember the obligations we owe. These are important lessons only a veteran can teach us.

Phase two of the project will include a maintenance fund for upkeep and repairs to the site. Planned improvements include an entrance marker, additional landscaping, a pedestrian bridge over Gallagher Creek, and historical American documents exhibit.

Auto Insurance Bills Passed by State Senate: Legislation Would Shift Cost of Care Resulting from Catastrophic Car Injuries to Michigan Taxpayers

On June 7, the Michigan Senate passed Senate Bills

(SB) 1014 & 787, which would erode protections for residents who suffer catastrophic injuries in car accidents and shift the cost of care to Michigan taxpayers.

Specifically, if they ultimately become law, SB 787 and SB 1014 will change the law as follows:

### Below is a summary of Senate Bill 787:

- When an individual age 65 or over applies or renews an insurance policy, he/she shall select to cap benefits at either a \$50,000 or keep it at no maximum limit. (Under the current state of the law, there is no maximum limit.) If the insured selects to cap benefits at \$50,000, such cap only applies to the insured and the insured's spouse.
- This will inevitably lead to a greater number of persons age 65 or over enrolling in Medicare or Medicaid if they elected the \$50,000 and their medical bills in an accident exceed the cap.

### Below is a summary of Senate Bill 1014:

- Attendant care provided in the home by a family or household member is capped at "a reasonable and customary amount" for the first 56 hours of care provided per week and capped at \$15.00 per hour for each additional hour of care per week. These caps are to apply regardless of the level of care provided.
- No Fault benefits payable by the assigned claims plan are capped at no more than \$400,000.
- Creates the Michigan Automobile Insurance Fraud

Authority which provides support to programs designed to reduce the incident of auto insurance fraud. However, the bill makes no mention of providing or offering any support to reduce the incidence of fraud perpetrated by auto insurers.

Michigan Paralyzed Veterans of America is a member of the "Coalition Protecting Auto No- Fault (CPAN). CPAN President John Cornack issued the following statement in response to the Senate's last-minute ramming through of these bills just before the Senate left for their summer recess.

"These bills would turn anyone who doesn't own a car into second-class citizens, and the cost of their care would be shifted to Michigan taxpayers. This legislation would severely harm children, seniors, bicyclists and others who rely on public transportation, such as young professionals living in downtown Detroit.

"We are extremely sensitive to what Michigan drivers pay for auto insurance, particularly those who live on a fixed income, such as seniors. Unfortunately, this legislation does not adequately address the high costs of insurance in this state and does nothing to guarantee rate reductions.

"CPAN has fought for the creation of a balanced fraud authority, one which will fight fraud on all sides. This legislation, however, would protect only one side — insurers. Insurers win and consumers lose because the legislation would not investigate fraud in all forms."

"The bills passed by the Senate does not provide comprehensive reform to address the costs in the auto no-fault system, including real factors behind Michigan's auto insurance premiums: the discriminatory practice by insurance companies of using factors like credit scores, occupation, ZIP codes and gender to set rates."

CPAN has not stopped its efforts to find the necessary bipartisan support for a reform package that could receive legislative approval. Discussions continue with legislative leadership and certain House members willing to be thoughtful and seek balanced reform to achieve cost savings.

MPVA agrees that Michigan auto insurance rates need to be lower. SB 1014 & 787 are not the solution. This legislation is a bad deal for Michigan drivers and accident victims. In fact, the only group that benefited

from the bill will be the auto insurance industry which would have seen benefits capped for accidents victims and no permanent requirement to lower costs. It is time for the Legislature to consider a real solution with strong bipartisan support that would provide rate relief for all drivers without gutting benefits.

Once again, MPVA is calling on Michigan legislators to enact laws that require the MCCA to release financial information so both policy makers and interest groups can make informed decisions on proposed changes to the Michigan No-Fault law.

The information is critical in revealing to Michigan citizens and lawmakers the rationale behind the insurance industry claim that Michigan's current auto no-fault system is financially unsustainable and that the MCCA will soon go bankrupt without capping benefits and enforcing strict cost controls.


To date, the MCCA has continued to assert its claim of exemption from all attempts to secure this essential information – including the recently-filed FOIA lawsuit by CPAN – effectively blocking the ability of all concerned parties to assess the no-fault system, address its shortfalls, and collaborate on appropriate solutions to fix the system without sacrificing no-fault's core principle of immediate access to appropriate, unlimited care for catastrophically-injured victims.


This is about transparency and access to information. The MCCA is a public body that collects millions of dollars from millions of Michigan citizens, including our state lawmakers, and we have a right to see the records of how that money is managed.


The MPVA believes that the Michigan No-fault system provides the best insurance value in the country and needs to be maintained. Since the early 1990's insurance companies have been attempting to impose strict controls, reduce benefits and promote other reforms that would eliminate no-fault as it is known in Michigan today.


Each attempt has ended in the same result: with lawmakers and the public reaffirming their support for a system that allows people seriously injured in an auto accident to get the medical care they need without bankrupting their families and turning to welfare.








